ABOUT HOPWA

The HOPWA Program is the only federal program dedicated to the housing needs of people living with HIV/AIDS and their families. HOPWA supports persons living with HIV/AIDS (PLWHA) by providing them with safe and sanitary housing and an overall stable living environment.

In addition, HOPWA provides the supportive services necessary to maintain housing stability, gain better access to care, and enhance quality of life.

HOPWA ELIGIBILITY

Low-income persons (at or below 80 percent of area median income) that are medically diagnosed with HIV/AIDS and their families are eligible to receive HOPWA-funded assistance.



FREQUENTLY ASKED QUESTIONS

- Q. How do I become a participant in the HOPWA Program?
- A. All participants must be referred through the Coordinated Entry System. Please contact a MOHS Coordinated Access Navigator to complete the screening process.
- Q. What documentation is required to determine eligibility?
- A. · Coordinated Access assessment
 - Verification of HIV/AIDS diagnosis
 - Household income verification
 - Insurance card
 - Valid identification for all household members over 18
 - · Social Security Card(s)
 - Birth Certificate(s)
- Q. Is the rental subsidy voucher permanent?
- A. Yes, however, voucher holders must abide by all voucher guidelines and regulations. A voucher holder may choose to relinquish their voucher at any time.
- Q. Will a list of available units be provided?
- A. Your Housing Contract Specialist may be able to refer you to available units, landlords, or placement coordinators. However, it is the responsibility of the voucher holder to locate an available unit.
